3. To permit USSF membership registration at the tournament, and to provide the necessary forms for such registration;
4. To provide a complete report of the tournament (including all injuries that required medical attention, and new membership registrations and fees) to the USSF within five days of tournament completion;
5. To include the United States Sumo Federation as a "releasee" on the tournament waiver and release form;
6. To provide copies of the entry form, general information sheet, and waiver and release form with this application;
7. To acknowledge that failure to do any of the above, or to fulfill the terms of this agreement, may result in the forfeiture of future rights to sanctions;
8. To post the tournament sanction in public view at the tournament site.
